<b>Authority</b>	This event will be conducted under the Competition Rules of VSKC, SuperKart Racing Standing & Technical Regulations, these Supplementary Regulations and any further Regulations or instructions which may be issued and will be subject to VSKC/AIA Permit No. <b>BR180720/VSKC2003</b>
<b>Promoter</b>	The event will be promoted and organised by the Victorian Superkart Club Inc.

<b>Event Description</b>	The event will be a Club Superkart Race and is <b>Round 3</b> of the Victorian Superkart Club series. To be held at Broadford Motor Cycle Complex on the Road Circuit. The Circuit is 2.14km in length, hot mix surface and racing will be in a clockwise direction
<b>Entries</b>	Entries will <b>open</b> on the <b>publication of these regulations &amp; close</b> on <b>15 July 2020</b> Entry is via VSKC website or manual entry form and fees sent to: <b>Entry Secretary</b> <b>27 Candlebark Close, Diamond Creek, 3089</b> Entry Fee for the meeting as per Entry Form A separate fee is payable for each driver.  <b>Organisers reserve the right to refuse any entry in accordance with the VSKC 2020 club series rules</b>
<b>Insurance</b>	Both Public Liability and Personal Accident Insurance have been affected by the promoters.
<b>Classes</b>	The following classes will be catered for: 125cc Max Junior    125cc Max Light    125 cc Max Heavy 250cc International    250 cc National    125 cc Gear Box    125cc Stock Honda  <b>TO BE ELIGIBLE TO COMPETE DRIVERS MUST BE A FINANCIAL MEMBER OF THE VICTORIAN SUPERKART CLUB Inc. AND HOLD EITHER AN AIA CLUB RACING LICENSE OR HIGHER. DRIVERS MUST BE OVER THE AGE OF 12 TO ENTER THE MEETING.</b>
<b>Competition Format</b>	Superkart Competition will be of 1 Practice and 1 Qualifying ,3 heats of 7 laps and a final of 10 laps. All awarded points. The winner will be the driver with the highest points. In the case of a tie, the winner of the final will be declared the winner. Grids will be 2x2. Grid positions will be decided on qualifying times. Following Heats: grids will be determined from points accrued, with the exception of "P" plate drivers who will remain at the rear of the grid. Racing will be as per the 2020 VSKC Club Series rules. Flags or lights will be used for starting.
<b>Timing</b>	Vehicles competing in the events will be timed by an electronic timing device fitted to their karts
<b>Scrutiny</b>	Commences at <b>7.30am</b> . Finishes <b>9.00am</b> . <b>NO in-person scrutineering</b> . Self-declaration of vehicle safety and eligibility (on the provided form with the entry.) An audit may be carried out on selected vehicles during the weekend's activities.
<b>Driver Briefing</b>	This will be done by public address system with attendees adhering to social distancing requirements or via the use of technology. (It is compulsory for all drivers to attend) Practice begins <b>9.00 am</b> .  <b>Driver check in must be completed before any driver is permitted on track.</b> . (All competitors must present their current VSKC Club Racing license or higher, Log Book, Competition Records and Affiliated Club Membership Cards at driver check in in accordance with <b>social distancing</b> rules). All drivers must complete the <b>covid19 declaration</b> .
<b>Minimum Practice Required</b>	All drivers, other than those who hold a license and have previously competed or practiced at Broadford Motor Cycle Complex on the Road Circuit shall be required to complete at least three practice laps. In any case and with the approval of the Clerk of Course, drivers not completing such laps at the meeting shall be relegated to the rear of the field at the start of races.
<b>Racing Starts</b>	Approx. <b>10.00am</b>

<b>Pit crew</b>	Name of team personnel must be recorded on the allocated space on the entry form. Only <b>ONE</b> person is permitted per driver (no exceptions) All Pit Crew are required to sign the organiser's Indemnity form prior to them taking part in the meeting. Pre entry of pit crew is <b>mandatory</b> for this meeting. If you are not on the list at the gate you don't come in! All crew must complete the <b>covid19 declaration</b> .
<b>Mufflers</b>	All vehicles must be fitted with an effective muffler which diminishes the sound of the engines exhaust. All vehicles must be configured so that, when measured in competition conditions at a point 30 meters from the track edge, the sound emission from the vehicle does not exceed 95dB (A).
<b>Engine Noise</b>	Racing engines are <b>NOT PERMITTED</b> to be started before 8:00am or in operation after 6:30pm each day.
<b>Race Vehicles</b>	All competing vehicles must be located in the paddock area and must not be driven in the public area. Any breaches will result in the competitor being excluded from the meeting.
<b>Protests</b>	Any protests will be handled as per the dispute regulations of the Victorian SuperKart Club
<b>Abandonment</b>	Abandonment, cancellation and postponement will be in accordance with requirements of the Victorian SuperKart Club.
<b>Prizes</b>	Trophies will be awarded for 1st/2nd/3rd in each class, provided there are five (5) genuine entries within each class. There will be no gathering for presentation, trophies will be given to the winners at a separate time.
<b>Insurance</b>	All competitors are covered against personal accident in accordance with conditions benefits applicable to Victorian Superkart Clubs insurance Policy (Transwest) The VSKC has a Covid19 plan in place.
<b>Prohibited Areas</b>	Only such persons and vehicles as in the opinion of the Promoters is necessary or essential for the conduct of the meeting shall be permitted inside the safety-fenced area, including the Pre-Grid area. Persons under the age of sixteen unless in competition are not permitted in the Pit Area. The trackside Pits have a working lane and a through lane. Speed in pit lane should not exceed 40kph in the interest of pit-crew safety. Re-entry to the circuit shall be controlled by an official. The Victorian Superkart Club reserves the right to refuse entry to any person to during the course of the event at the Broadford Motor Cycle Complex.
<b>Crossing the Track</b>	Authorised personnel will only be permitted in the infield area. There will be no crossing the track after the one minute board has been raised, nor when cars are racing or practicing on the track. Any driver or pit crew breaching this regulation may be responsible for the exclusion of the relevant driver from the event, without prejudice to any further penalty deemed appropriate.
<b>Accommodation</b>	Staying overnight in any of the garages, carports or transporters in the Paddock Area is <b>NOT PERMITTED</b> during the period of the Meeting.
<b>Marquees</b>	No pegs are to be driven into the bitumen.
<b>Circuit Closure</b>	Competitor's vehicles or Pantecs or cars etc. are <b>NOT PERMITTED</b> entry to the circuit after 6:30pm.
